Introduction

- **1.1** This Basic Conditions Statement (BCS) has been produced to accompany Stisted Neighbourhood Plan (SNP).
- **1.2** The relevant legal framework for the preparation and making of neighbourhood plans is supported by the Localism Act 2011 and the Neighbourhood Planning Act 2017 and found in the:
 - Town and Country Planning Act 1990: ss. 61F, 61I, 61M-P and Schedule 4B
 - Planning and Compulsory Purchase Act 2004: ss 38A-C
 - Neighbourhood Planning (General) Regulations 2012 (2012 No.637) (As Amended)
- **1.3** Paragraph 8(2) of Schedule 4B to the Town & Country Planning Act 1990 requires a neighbourhood plan to meet five basic conditions before it can proceed to a referendum. These are:
 - (i) Having regard to national policies and advice contained in guidance issued by the Secretary of State it is appropriate to make the neighbourhood plan;
 - (ii) The making of the neighbourhood development plan contributes to the achievement of sustainable development;
 - (iii) The making of the neighbourhood development plan is in general conformity with the strategic policies contained in the development plan for the area of the authority (or any part of that area);
 - (iv) The making of the neighbourhood development plan does not breach, and is otherwise compatible with, EU obligations; and
 - (v) Prescribed conditions are met in relation to the neighbourhood plan and prescribed matters have been complied with in connection with the proposal for the neighbourhood plan. The prescribed condition is that the making of the neighbourhood plan does not breach the requirements of Chapter 8 of Part 6 of the Conservation of Habitats and Species Regulations 2017.
- **1.4** This document sets out how the Plan meets the Basic Conditions.

Key Statements

- **1.5** Braintree District Council (BDC), as the local planning authority, designated the Stisted Neighbourhood Area in December 2017. This enabled Stisted Parish Council to prepare the Stisted Neighbourhood Plan (SNP). The Plan has been prepared by the community through the Stisted Neighbourhood Plan Steering Group.




Figure 1.1 Stisted Neighbourhood Plan (SNP) Area

- **1.6** The SNP sets out policies that relate to the development and use of land within only the Stisted Neighbourhood Area. This area is shown in **Figure 1.1**.
- **1.7** The Plan refers only to the administrative boundary of the parish of Stisted. There are no other adopted Neighbourhood Development Plans that cover the Stisted Neighbourhood Area.
- **1.8** Stisted Parish Council has prepared the Plan to establish a vision for the future of the parish. The community has set out how that vision will be realised through planning and controlling land use and development change over the plan period 2024 to 2033.

Basic Condition (i) – Conformity with National Planning Policy

2.1 To meet this condition, the Plan must be shown to have regard to national policies and advice contained in guidance issued by the Secretary of State. National policy and guidance is contained within the National Planning Policy Framework ('NPPF') and the Planning Practice Guidance ('PPG').

National Planning Policy Framework

- 2.2 The NPPF has 13 key objectives:
 - 1. Delivering a sufficient supply of homes
- 2. Building a strong, competitive economy
- 3. Ensuring the vitality of town centres
- 4. Promoting healthy and safe communities
- 5. Promoting sustainable transport
- 6. Supporting high quality communications
- 7. Making effective use of land
- 8. Achieving well-designed places
- 9. Protecting Green Belt land
- Meeting the challenge of climate change, flooding and coastal change
- 11. Conserving and enhancing the natural environment
- 12. Conserving and enhancing the historic environment
- 13. Facilitating the sustainable use of minerals
- **2.3** This Basic Conditions Statement (BCS) explains how the Plan contributes to meeting these objectives. It also explains how the policies within the Neighbourhood Plan intend to meet, support and supplement specific national policies.
- **2.4** The Plan has 7 objectives (Objectives 1-7). These objectives are summarised in **Table 2.1** alongside the NPPF goals that each objective seeks to address.
- **2.5** Table 2.2 sets out each policy of the SNP alongside the policies in the NPPF that is has had regard to and analyses how each Plan policy contributes to achieving the key objectives of the NPPF.

Basic Condition (iv) – Contribution to Sustainable Developments

- **3.1** The NPPF states in paragraph 10 that a presumption in favour of sustainable development is at the heart of the NPPF.
- **3.2** For the Plan, sustainable development has been the fundamental basis of each of its policies. The National Planning Practice Guidance advises that 'sufficient and proportionate evidence should be presented on how the draft neighbourhood plan ... guides development to sustainable solutions'. The evidence base presented alongside the Plan, coupled with the reasoned justification for each policy in the Plan, demonstrates how the Plan guides development towards sustainable solutions.
- **3.3 Table 3.1** summarises how the objectives and policies in the SNP contribute towards sustainable development, as defined in the NPPF. Many of the objectives of the SNP overlap the three strands of sustainability, so for the purposes of this document, the most relevant strands have been taken to illustrate conformity.

3.4 As demonstrated in **Table 3.1**, the SNP objectives are considered to comprise a balance of social, economic and environmental goals. The policies of the SNP demonstrably contribute to sustainable development in respect of building a strong, responsive economy, supporting a strong, vibrant and healthy community and protecting and enhancing the natural and historic environment.

Basic Condition (v) – General Conformity with the Strategic Policies of the Development Plan

- **4.1** The development plan currently consists of:
 - Adopted Braintree District Local Plan section 1 adopted February 2021, section 2 adopted July 2022.
 - Essex Minerals Local Plan adopted July 2014
 - Essex and Southend-on-Sea Waste Local Plan adopted July 2017.
- **4.2 Table 4.1** details the SNP policies alongside a consideration of how they are in general conformity with each strategic policy in the development plan.
- **4.3** Where a policy is not identified in **Table 4.1**, it is considered that the SNP does not contain any policies that directly relate to it.

Basic Condition (vi) – Conformity with EU Obligations

- **5.1** The Plan and the process under which it was produced conforms to the SEA Directive (EU 2001/42/EC) and the Environmental Assessment of Plans and Programmes Regulations 2004 (the Regulations).
- **5.2** In November 2024, Braintree District Council published a draft Strategic Environmental Assessment (SEA) Screening Report, prepared by Place Services. This considered that the Stisted Neighbourhood Plan could be screened out for its requirement of Strategic Environmental Assessment in line with the requirements of Directive 2001/42/EC. This was then consulted on with the statutory bodies (the Environment Agency, Natural England and Historic England). The representations received from the statutory bodies agreed with this assessment and the final Screening Report was published alongside the Submission Version (Regulation 16) of the Stisted Neighbourhood Plan.

Basic Condition (vii) – Conformity with the Prescribed Conditions

- **6.1** Under Directive 92/43/EEC, also known as the Habitats Directive, it must be ascertained whether the draft Plan is likely to breach the requirements of Chapter 8 of Part 6 of the Conservation of Habitats and Species Regulations 2017. Assessments under the regulations are known as Habitats Regulation Assessments ("HRA"). An appropriate assessment ("AA") is required only if the Plan is likely to have significant effects on a European protected species or site.
- **6.2** In November 2024, Braintree District Council published a draft Habitats Regulations Assessment (HRA) Screening Report, prepared by Place Services. This considered that the Stisted Neighbourhood Plan without mitigation, further consideration was required at the Appropriate Assessment stage to determine whether the Regulation 16 Submission Stisted Neighbourhood Plan either alone or in-combination with other plans and projects, would adversely affect the integrity of Habitats sites as a result of the recreational disturbance potential impact pathway. Specifically the HRA recommended that Policy STIS9 should be re-assessed further due to predicted recreational impacts from the Plan alone.
- **6.3** The AA testing established that, based on the proximity to Habitats sites and in order to be in accordance with the Essex Coast Recreational Disturbance Avoidance and Mitigation Strategy (RAMS), mitigation needed to be embedded in the Plan in relation to recreational disturbance to avoid impacts from the Neighbourhood Plan in combination with other plans and projects. Therefore, the HRA recommended that Policy STIS9 and its supporting text be altered.
- **6.4** This was then consulted on with the statutory body (Natural England) which agreed with the assessment. The amendment was made in the Submission Version (Regulation 16) of the Stisted Neighbourhood Plan. The final HRA and AA was published alongside the Neighbourhood Plan.

Chapter 7 Conclusion

7.1 The relevant Basic Conditions as set out in Schedule 4B to the TCPA 1990 are considered to be met by the Stisted Neighbourhood Development Plan and all the policies therein. It is therefore respectfully suggested to the Examiner that the Stisted Neighbourhood Development Plan complies with Paragraph 8(1)(a) of Schedule 4B of the Act.
